I have submitted to the events groups our willingness to participate in pop ups in Bigge Park and requested we be included in #Livoflashbacks a social media series. I was heartened when we had a Bunnings fundraiser this year and another that was COVID cancelled. They both showed a willingness for members to form teams and volunteer to help. We need that in spades as we go forward. I know that an organization is only as good as those who champion it and want it to succeed. I hope to continue be one of those people.
